

SMS Terms and Conditions (the “Agreement”)

DEFINITIONS

“You” means the person or entity who participates in or uses the Service in any way.

“SWN,” “we,” “our,” “us,” and “provider” means SWN Communications Inc., as well as any other person or entity providing any service, applications or content from us or on our behalf.

“Service” means SWN’s on-demand alerting and incident response services. SWN provides the Service to its customers for both routine and emergency communications to designated groups of recipients across a variety of platforms, including SMS text messaging, to the communication device of each recipient’s choice.

ACCEPTANCE BY YOU

Our customers may enroll you or ask you to enroll in the Service. By using the Service provided by us, you have agreed to be bound by the terms and conditions of this Agreement. If you do not agree with this Agreement, you must immediately cease using the Service and contact us as provided below.

CHARGES

We will not separately charge individual recipients of SMS text messages for the messages they receive from our Service. However, message and data rates may apply from your mobile carrier in accordance with your wireless customer agreement with your carrier. You should consult your wireless service provider regarding its pricing plans.

PARTICIPATING CARRIERS

The Service is available through Verizon Wireless, AT&T, MetroPCS, Sprint, Boost, T-Mobile, Alltel, Virgin Mobile, and U.S. Cellular. Additional carriers may be added without notice.

Carriers are not liable for delayed or undelivered messages.

PARTICIPANT OPT-OUT OR HELP

You are responsible for managing the types of SMS text messages you receive. If you have any questions or need help, text **HELP** to 38671 or 82104. To stop receiving text messages, text **STOP** to 38671 or 82104. After doing so, you will receive confirmation of your opt-out and, thereafter, you will no longer receive text messages from us.

AUTOMATIC DIALING

We may use an automatic dialing system to deliver text messages to you. By your use of the Service, you give your consent to us to use an automatic dialing system to deliver text messages to the telephone or cell phone number that you have provided to transmit these text messages.
